The meeting was called to order at 10:05 a.m. by Ms. Libby Messick.

Upon reviewing the minutes of the October 12, 2022, meeting, a motion to approve the minutes was made by Mr. Toby Bennington and was seconded by Mr. Rodney McCain.

OLD BUSINESS:

There were no old business items to discuss.

NEW BUSINESS:

Ms. Messick called for review of the FY 20-23 TIP Spreadsheet and Administrative Modifications. She gave the members handouts of the list of MPO projects. Ms. Messick explained that there were no administrative modifications that created changes on the TIP spreadsheet and four administrative modifications that did not create changes to the TIP spreadsheet.

Ms. Messick then called for discussion of Resolution No. 840. Ms. Messick explained this resolution is to adopt and support the Statewide Performance Measurement Targets for Safety (PM1), Bridge and Pavement Performance (PM2), and FHWA System Performance (PM3). She explained PM1 targets are updated and adopted annually while PM2 and PM3 targets are updated and adopted bi-annually. A screenshot of the ALDOT safety portal was provided to show the MPO area is currently supporting PM1 targets. Mr. Rodney McCain asked if PM2 would create requirements for future programming. Ms. Messick stated she would double check with ALDOT but was not aware of any requirements for programming with these Performance Measures. A motion was made by Mr. Toby Bennington to approve this amendment with **Resolution No. 840**, which was seconded by Mr. Rodney McCain. Motion carried.

Ms. Messick next called for discussion of Status Report of Pre-Construction projects. Mr. Michael Burgh reported project #30 Reconfigure intersection US-78 and Barry is on time for December Let; project #41 bridge replacement on Airport Rd at Coldwater creek is working on environmental and plans and will

need an extension from FHWA for PE funding; #48-50 Friendship Rd from Cheaha Dr to Circle Drive all 3 phases will need TS&L and draft hydraulic study; #33 Chief Ladiga Trail had a subliminal manday submitted and approved. Mr. Michael Burgh also reported resurfacing on 431 north of 144 would be letting in February of 2023 and resurfacing on 21 from Walmart to the Oxford High School would be let in April of 2023. Mr. Rodney McCain reported for project #44, Installation of a Roundabout at Bynum Leatherwood Rd and Old Gadsden Highway is on schedule for January 23 Let.

Ms. Messick next called for discussion of Status Report of ALDOT projects. Mr. Shane Brown reported US-431 access management and I-20 resurfacing from Snow Creek to the Calhoun/Cleburne County line are both working on punch list items and awaiting final acceptance; US-431 resurfacing from 0.28 miles south of SR 204 to the Etowah County line is on contract for shoulder treatment; I-20 resurfacing from H.J. Bentley Jr. Overpass to Snow Creek is awaiting permanent stripe; and Russell Drive resurfacing and traffic stripe will be pushed to spring due to seasonal limitations. Mr. Matt Hawes also reported that Henry Rd resurfacing would also be pushed to spring due to seasonal limitations.

Next, Ms. Messick continued by calling for discussion of Safety Observations. She explained that there was a handout in the agenda packet with the list of concerns from the CAC that had been discussed at previous meetings for review. There were a few items that had been updated from the previous month. No further updates were available.

Next, Ms. Messick called for the Report on Urban Fixed Route and ADA Handicapped Transit Systems. She reported the ADA Paratransit Ridership for Anniston had 474 (decrease) one-way trips, Jacksonville had 117 (decrease) one-way trips, 43 trips for Weaver (decrease), and Oxford had 65 (decrease) one-way trips. For the Urbanized area 118 (decrease) one-way trips and 114 (same) one-way trips for the Rural area. Fixed-route ridership had a total of 7,483 (decrease) riders for the month of October.

The next TAC meeting will be Wednesday, December 7, 2022, at 10:00 a.m.

There being no other business to discuss, the meeting was adjourned at 10:23 a.m.

Increase PE Funds for Project #45 (100064898) Resurfacing Russell Drive from Peaceburg Rd to Alexandria Rd

WHEREAS, the Calhoun Area Metropolitan Planning Organization (MPO) has adopted its FY 2020-23 Transportation Improvement Plan (TIP) on August 15, 2019 with Resolution #788; and
