The meeting was called to order at 10:00 a.m. by Chairman Miller Parnell.

#### **OLD BUSINESS:**

Minutes of the CAC meetings from September 20, 2023, were approved on a motion by Mr. Tim Huddleston and seconded by Mr. Bruce Britton. Motion carried.

Chairman Parnell called for a discussion of October 2023 Administrative Modifications and Resolutions. Ms. Messick explained that there was a list of modifications in the agenda packet to review that were discussed during the previous month to keep the members of the CAC up to date. There was one modification that created changes to the TIP and no modifications that did not create changes to the TIP spreadsheet during these months. Ms. Messick also reported there were no resolutions adopted in October.

#### **NEW BUSINESS:**

Chairman Parnell called for the Review of FY 20-23 TIP Update and Administrative Modifications. Ms. Messick explained that there were eight administrative modifications that created changes to the TIP spreadsheet and no administrative modifications that did not create changes to the TIP spreadsheet.

Chairman Parnell then called for a discussion of Resolution No. 860. Ms. Messick explained this resolution was to adopt and support the ALDOT Statewide Performance Measurement Targets: Safety (PM1). She explained this was an annual update and adoption. A motion was made by Mr. Tim Huddleston to approve this certification with **Resolution No. 860**, which was seconded by Mr. Lem Burell. Motion carried.

Chairman Parnell then called for discussion of Resolution No. 859. Ms. Messick explained this resolution was to increase CN funds for project #48 100070250 Phase I- Wideing and Improvements on Friendship Rd from Cheaha Drive to Circle Drive. Discussion for Resolution 858 included moving phase II of this project to fiscal year 2026 to maintain fiscal constraint. The City of Oxford agreed and this will be done by administrative modification the following month. A motion was made by Mr. Jamie Etheredge to approve this amendment with **Resolution No. 859**, which was seconded by Ms. Julie Borrelli. Motion carried.

Chairman Parnel next called for discussion of Status Report of Pre-Construction projects. Ms. Messick explained the TAC would be reporting on preconstruction projects to keep the MPO updated on how the projects were progressing. She reported Project 33 had sent final back check comments and construction submission would be soon after; Project 41 is waiting on signature for the design exception; Project 49 is still working on hydro; and Project 57 has been submitted to OE but needs a signed title sheet from Jacksonville.

Chairman Parnell next called for discussion of Status Report of ALDOT projects. Ms. Messick reported the reconfiguration of the intersection at US 78 and Barry St has utility conflicts, and US 431 resurfacing from just north of SR-144 to 0.28 miles south of SR-204 just finished RPMS and is waiting on sweeping and acceptance with punch list items.

Chairman Parnell continued by calling for discussion of Safety Observations. Ms. Messick explained that there was a list of previous observations in the agenda packet for review. Ms. Messick explained there were two updates. One from item #36 which the county is trying to acquire some backplates for the signal heads to aid in making them stand out from the surroundings. The second from item #36 that the SR-21 access management will also include signal upgrades and this will be addressed then. Mr. Fred Denney also reported that Mr. DeJarvis Leonard had taken an interest in the Bynum Blvd/Hwy 202 intersection so there may be movement soon on this issue.

Chairman Parnell next called for a discussion of MPO Boundaries from 2020 Census Data. Maps were provided to show the suggested boundaries from the recent Census as well as current boundaries. Ms. Messick reported the TAC agreed to extend where possible but leave all other boundaries the same.

#### **OTHER BUSINESS:**

Chairman Parnell called for a discussion of CAC vacancies. Anniston has 9 vacancies, Jacksonville has 2, and Oxford has 8 vacancies. The subcommittee planned on getting together soon to set a date and time to meet before the next scheduled meeting. It was requested a

discussion and vote for moving CAC meetings to monthly instead of bi-monthly be added to January's agenda.

Next, Chairman Parnell called for the report on Urban Fixed Route and ADA Handicapped Transit Systems. Ms. Messick Ms. Messick reported the ADA Paratransit Ridership for Anniston had 450 (increase) one-way trips, Jacksonville had 131 (decrease) one-way trips, 21 trips for Weaver (increase), and Oxford had 70 (increase) one-way trips. For the Urbanized area 95 (increase) one-way trips and 31 (increase) one-way trips for the Rural area. Fixed-route ridership had a total of 7,033 (increase) riders for the month of October.

The next CAC meeting was scheduled for Wednesday, January 17 at 10:00 a.m.

There being no further business, a motion was made by Mr. Tim Huddleston and seconded by Mr. Johnny Phillips to adjourn. The meeting was adjourned at 10:43 a.m.
